REASONS FOR DECISION

This is an application to assign water use licence PM03-353, a B licence for placer undertaking, and Placer Mining Land Use Operating Plan Approval AP03353 from David Kosuta & Greg McNeil to Greg McNeil

The Licence was issued October 29, 2004. The Mining Land Use Operating Plan approval was issued October 29, 2004. An Environmental Assessment was completed in accordance with the requirements of YESAA. The assignment does not constitute any change to the project, except a change to the name of the proponent.
